When Program Participants (e.g., Applicants, Semi-Finalists, Finalists, Fellows, Alumni, and former) access the Apply Site of the PMF Program's Talent Management System (PMF TMS), they agree to the Full Terms and Conditions of Use. Below is a copy of the Full Terms and Conditions of Use.

Annual PMF Application and Assessment Process:

The PMF Program requires that all candidates agree to maintain the confidentiality and security of its assessment materials and procedures. Please read and affirm your understanding and compliance with the statements below.

- I understand I am on my honor to complete the online assessment without assistance.
- I understand that the content of this assessment is considered secure assessment material, is the property of the Presidential Management Fellows Program and I am not permitted to record, screenshot, retain, copy, download, reproduce, photograph, store, distribute, or otherwise save or transfer information to any individual or group, through any means.
- I understand that I am not permitted to discuss or share the materials or contents of this assessment with anyone at any time, during and after assessment administration.
- I understand that it is my responsibility to take reasonable measures to restrict access to the information while in my possession, including appropriate destruction of notes I may have taken during any of the assessments.
- I agree and acknowledge that in preparing for any of the assessments I have not accepted, used or relied upon items represented to me as actual items on the assessments and that accepting and/or sharing such items will constitute a breach of the terms and conditions of use and can result in consequences otherwise outlined.
